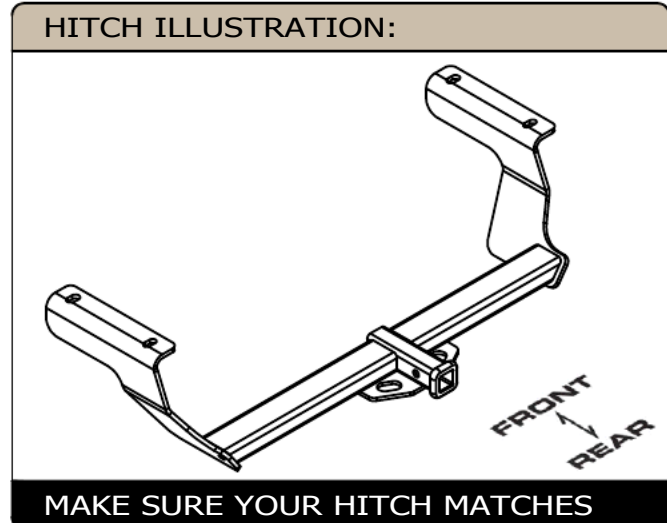

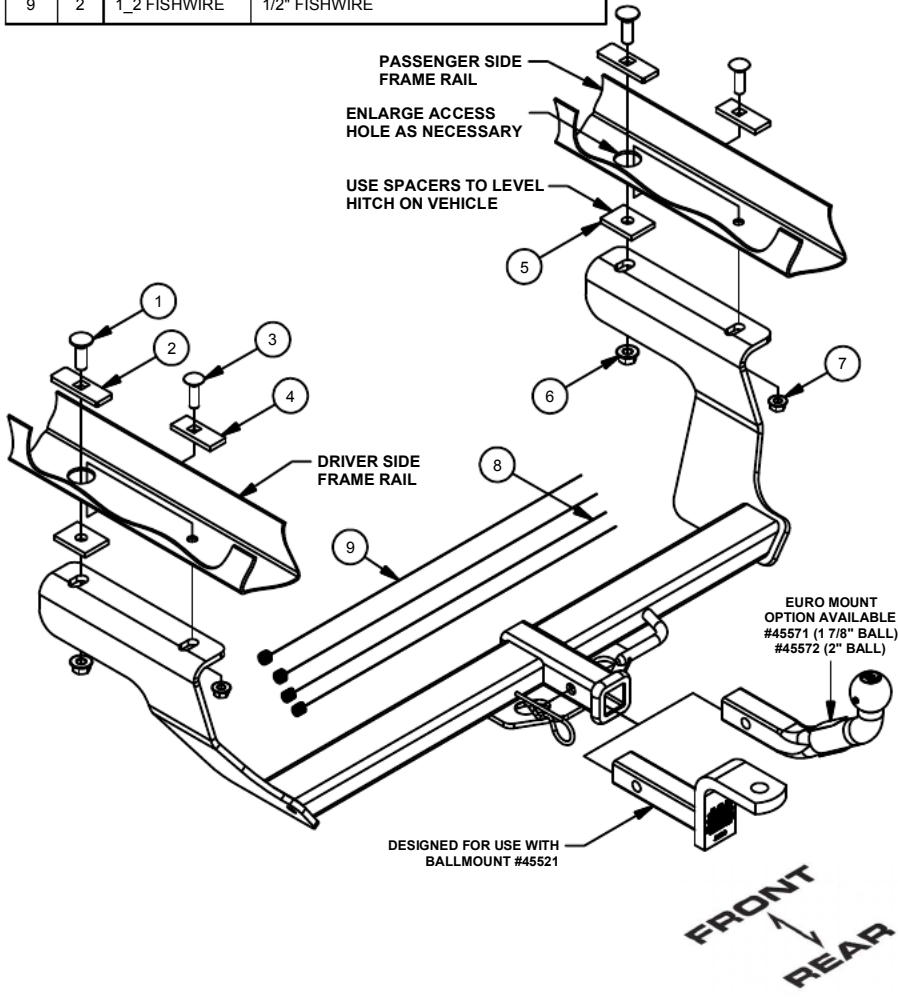

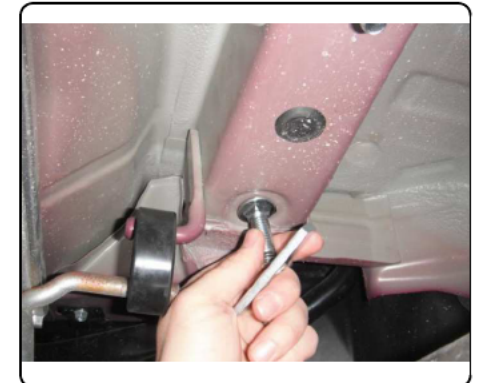

1) Remove the (4) plugs in the frame rails and return to vehicle owner (leave center plugs in).



2) Fishwire 7/16" carriage bolts and CM-SP11 spacers into position first and reverse fishwire 1/2" carriage bolts and CM-SP6 spacers into position afterward. (enlarge access hole as necessary)

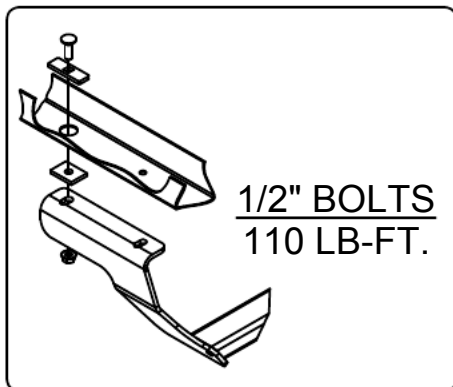
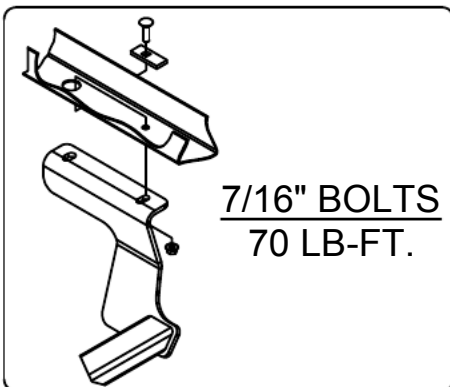


INSTALLATION WALKTHROUGH:

- 3) Raise hitch to the frame aligning the holes in the hitch with the bolts. Use 1.50" x 2.00" spacers to level hitch as necessary. Install remaining supplied hardware, as shown on page 2.
Note: Be careful not to push the bolts into the frame.



- 4) Torque all 7/16" fasteners to 70 lb-ft, and all 1/2" fasteners to 110 lb-ft.

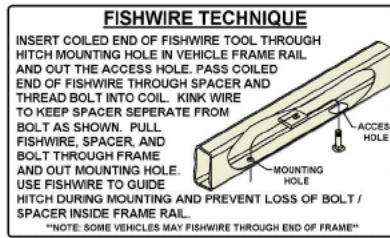

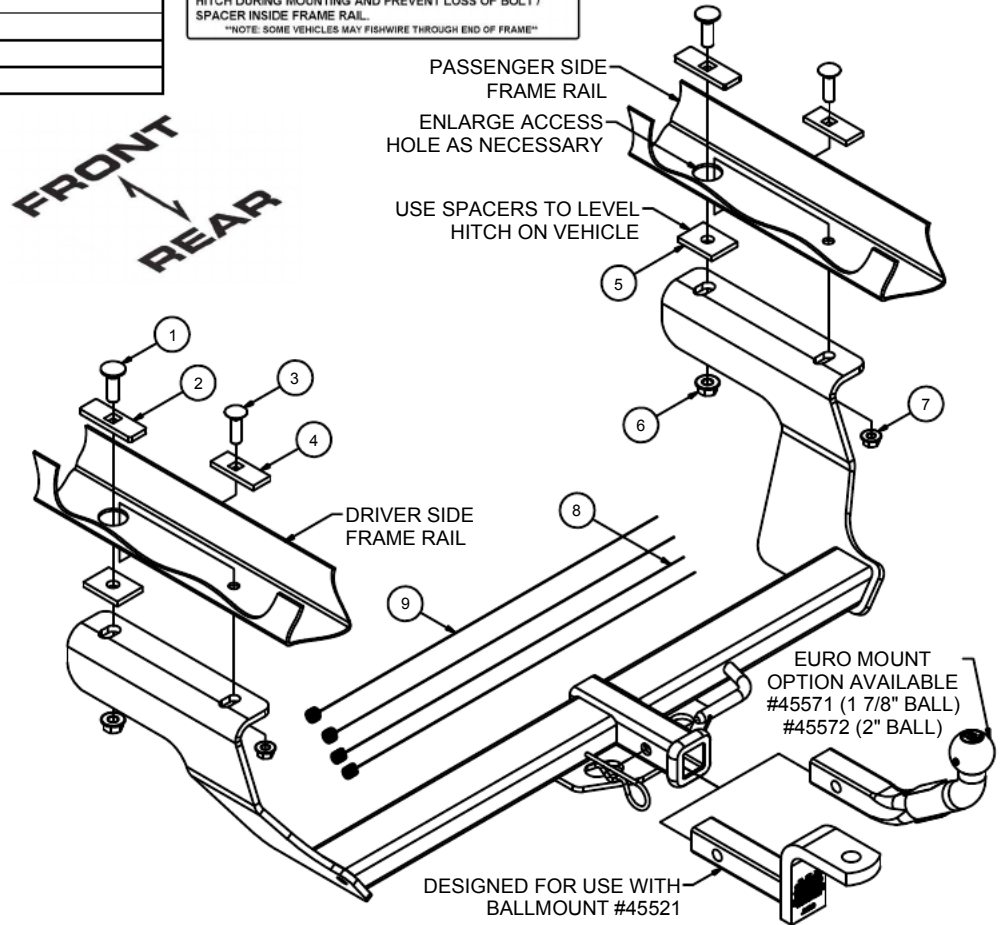
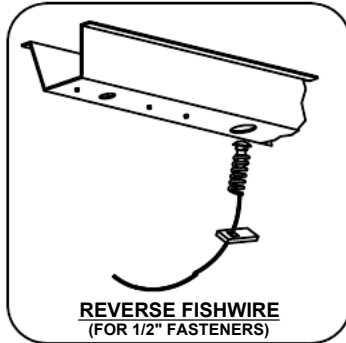

INSTALLATION STEPS

- 1) Remove the (4) plugs in the frame rails and return to vehicle owner (leave center plugs in).
- 2) Fishwire 7/16" carriage bolts and CM-SP11 spacers into position first and reverse fishwire the 1/2" carriage bolts and CM-SP6 spacers into position afterward. (enlarge access hole as necessary)
- 3) Raise hitch to the frame aligning the holes in the hitch with the bolts. Use 1.50" x 2.00" spacers to level hitch as necessary. Install remaining supplied hardware, as shown above.

NOTE: Be careful not to push the bolts in the frame.

- 4) Torque all 7/16" fasteners to 70 lb-ft, and all 1/2" fasteners to 110 lb-ft.
